## **Nomination by the Chairpersons of Councils of Public Universities Council to serve as a Member of the Commission for University Education.**

The Universities Act No. 42 of 2012 was amended and assented to on 23<sup>rd</sup> December 2016, as the Universities (Amendment) Act No. 48 of 2016.

The Commission for University Education is established by Section 4 of the said Act. Section 6 (1) (f), requires the Chairperson of Councils of Public Universities to nominate one person, to serve as a member of the Commission.

This is a call for persons who meet the relevant criteria outlined below to express interest in serving as a Commissioner of the Commission of University Education for consideration for nomination by the Chairperson of Councils of Public Universities.

Persons interested in the nomination must meet the following minimum requirements;

1. Have a Master's Degree;
2. Have at least ten years experience in governance and management of University Education;
3. Be a Scholar with experience and in training and research;
4. Have Demonstrable capacity for Resource mobilization;
5. Have global exposure on University education;
6. Be of high moral character and integrity in accordance with Chapter Six of the Constitution and capable of contributing to University education.

In addition, the person should **NOT** be a current member of any University Governing Council or Management.

The Application should include:

1. A cover letter
2. A detailed *Curriculum Vitae* with three referees
3. Copies of testimonials

The applications should be addressed and submitted to the undersigned in a sealed envelope clearly marked “**NOMINATION BY CHAIRPERSONS OF COUNCILS OF PUBLIC UNIVERSITIES TO THE COMMISSION FOR UNIVERSITY EDUCATION**” not later than 14<sup>th</sup> March 2017 at 5pm:
